Background

The Commission on Homelessness and Housing for Volusia & Flagler Counties is a collaborative of citizens, government, and faith-based and social service organizations whose purpose is to prevent and end homelessness. The CoHH model was created by the U.S. Department of Housing and Urban Development and communities that apply for and receive federal funding to house the homeless must operate a CoHH that works to meet the requirements of the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (HEARTH Act).

Initial Board Selection Process

The Commission on Homelessness and Housing for Volusia & Flagler Counties Board will consist of an odd number of members totaling no less than 21 and no more than 27. Pursuant to the Interim Rule, the Board will be representative of the relevant organizations and providers serving homeless subpopulations. The initial board will consist of representatives from the following organizations or designations. Qualified representatives must apply and be elected by vote of the CoHH membership. The Board, once selected, may appoint representatives from open categories, at any time, consistent with the membership limit and other policies and procedures set forth below.

The Officers of the Board will be Chair, Vice-Chair, and Secretary. Officers will be elected by the CoHH membership. Every 2 years candidates will indicate candidacy for Chair, Vice-Chair or Secretary on his or her application. There are currently no officer positions open.

Purpose and Term of the Initial Board of Directors: To lead the CoHH members through the Adoption of the Governance Charter that includes policies and procedures and designating roles and responsibilities of the Board, Collaborative Applicant, and HMIS Lead and all other requirements as set forth in the HEARTH Act and Interim Rule.
